CHAP. 89.

William I. Alcock, Robert C. Long, Leonard Poudre, Philip Horn, John Wilson, Jacob Adams, John Lynch, John M.Kinnel, George Peters. John Redy and William B. Lupton, or a majority of them, to propose a scheme of a lottery or lotteries for raising a sum of money, not exceeding fifteen thousand dollars, clear of all expenses in drawing said lottery or lotteries, and to dispose of the tickets thereof: Provided, the said Archibald George, Peter Forney, William I. Alcock, Robert C. Long, Leonard Poudre, Philip Horn. John Wilson, Jacob Adams. John Lynch, John McKinnel, George Peters, John Redy and William B. Lupton, or a majority of them as shall undertake to act under this law, shall, before the sale or disposal of any ticket or tickets in said lottery or lotteries, give their bond to the state of Maryland in the penalty of thirty thousand dollars, conditioned that they will well and truly apply so much of the money arising therefrom, within six months after the drawing of said lottery or lotteries, as will satisfy the fortunate adventurers for prizes drawn by them, and shall, within twelve months after the drawing thereof, apply the money raised by such lottery or lotteries to the paving of that part of the road which runs through the alms-house ground.

Bond to be lodged in clerk's office.

3. And be it enacted, That it shall be the duty of the said commissioners, before they act as such, to lodge the bond entered into as aforesaid in the office of the clerk of Baltimore county, there to be recorded, and upon such bond, or any office copy thereof, suit or suits may be instituted against the obligors therein, or any of them, or their legal representatives, for any breach or noncompliance with the conditions of the same.

Tickets may be sold in any part of the state,

4. And BE IT ENACTED, That the commissioners be and they, or any person or persons appointed by them, are hereby authorised to dispose of and sell all or any of the tickets of said lottery or lotteries in the city of Baltimore, or any other part of this state, exclusive of any control of the same by the corporation of the city of Baltimore, any law or usage to the contrary notwithstanding.

Benefit of insolvent laws extended to him. BE IT ENACTED, by the General Assembly of Maryland, That the judges of Baltimore county court, be and they are hereby authorised and directed, to extend to William Maxwell, of the city of Baltimore, the benefit of the act of assembly passed at November session, eighteen hundred and five*, entitled, An act for the relief of sundry insolvent debtors, and the several supplements thereto, without requiring the said William Maxwell to produce the assent, in writing, of two thirds of his creditors, as is prescribed by the provisions of the said act and supplements.
