CHAP. C.

An Act to pay the Civil List, and other expenses of Civil Government. Lib. TH. No. 2, fol. 568.

СНАР. 100. Passed Dec. 24.

WHEREAS those who dedicate their time, abilities and labour, to Preamble. the public, ought to receive a reasonable and adequate compensation for their services:

2. BE IT ENACTED, by the General Assembly of Maryland, That Officers salaries, the following officers of civil government, for the time being, shall be entitled to receive at the rate of the following salaries, in current money, for the ensuing year, to wit: The treasurer of the western shore, two thousand dollars; the treasurer of the eastern shore, four hundred and fifty dollars; the auditor, eight hundred dollars; the clerk of the council, eight hundred dollars; the clerk of the senate, one hundred and fifty dollars; the clerk of the house of delegates, three hundred dollars; the printer to the state, twelve hundred dollars; the messenger to the council, two hundred and fifty dollars.

S. AND BE IT ENACTED, That all monies which shall remain in Monies to be first the treasury after discharging the journal of accounts, and all un-ment thereof. appropriated money which may come into the treasury, be first applied to the payment of the civil list for the ensuing year.

CHAP. CI.

CHAP. CII.

An Act for the benefit of Jacob Kiler. Lib. TH. No. 2, fol. 570. BE IT ENACTED, by the General Assembly of Maryland, That Benefit of insolvent laws extended the judges of Frederick county court, he and they are hereby au-ed to him. thorised and directed, to extend to Jacob Kiler the benefit and relief of the act of assembly passed at November session, eighteen hundred and five*, entitled, An act for the relief of sundry insolvent * ch. 110, debtors, and the supplements thereto, without compelling him to produce the assent of two-thirds in amount of his creditors, and to extend and afford to him all the benefits, advantages and provisions, of the aforesaid act, and the supplements thereto, in the same manner, and upon the same terms and conditions, as if he had obtained the assent of two-thirds of his creditors to his release under the same.

CHAP. CIII.

An Act to authorise the filling up and extending of certain Lots on the Passed Dec 24. south side of the Basin in the City of Baltimore. Lib. TH. No. 2. fol. 571.

WHEREAS Christopher Hughes, of the city of Baltimore, by his Preambles petition to this general assembly, hath set forth, that for the want of convenient wharfs on the south side of the Basin in said city, that part of the city, and persons trading by water to the said city, are deprived of many advantages which they would otherwise enjoy, and that his property is thereby materially injured, and hath therefore prayed that a law might pass, granting him, as the pro-
