

tained by any person or persons through whose land the said road may pass by opening and clearing the same. CHAP. 120.

3. AND BE IT ENACTED, That the damages so assessed shall be paid or secured to be paid to the individuals concerned, by the persons interested in opening the said road, before the same shall be opened. Payment of damages.

4. AND BE IT ENACTED, That the said commissioners, or a majority of them, are hereby directed to make out a plot of said road as laid out and marked by them, and return the same to the clerk of Worcester county court, who shall record the same. Plot to be returned to clerk of county court.

5. AND BE IT ENACTED, That when the said road shall be laid out, cleared, opened and made passable, the same shall for ever thereafter be deemed and taken for a public road, and shall be kept in repair in the same manner that other public roads are kept in said county. When laid out to be deemed a public road.

6. AND BE IT ENACTED, That the persons interested in opening the said road shall pay the reasonable expenses for laying out, surveying and returning a plot of the same. Persons interested to pay expenses.

CHAP. CXXI.

An Act for the relief of James Davidson Johnson, of Worcester County. Passed Dec. 27.

BE IT ENACTED, by the General Assembly of Maryland, That the justices of the levy court of Worcester county shall be, and they are hereby directed and empowered, at their levy court annually, so long as they shall see cause, to assess and levy on the assessable property of said county, a sum of money not exceeding thirty dollars, nor less than twenty dollars, for the support and maintenance of James Davidson Johnson, of said county; and that the same be collected annually by the collector of said county, and paid to such person or persons as the levy court of said county shall or may direct. Levy authorised for his support

CHAP. CXXII.

An Act for the relief of Sater T. Walker, an Insolvent Debtor, of the City of Baltimore. Passed Dec 27.

BE IT ENACTED, by the General Assembly of Maryland, That the judges, or any one judge of Baltimore county court, be and they, or any one of them, are hereby authorised and directed to extend to Sater T. Walker, the benefit and relief of the act of assembly passed at November session eighteen hundred and five*, entitled, An act for the relief of sundry insolvent debtors, and the supplements thereto, without compelling him to produce the assent of two-thirds, in amount, of his creditors, and to extend and afford to the said Sater T. Walker all the benefits, advantages and provisions, of the aforesaid act and the supplements thereto, in the same manner, and upon the same terms and conditions, as if he had obtained the assent of two-thirds of his creditors to his release under the same. Benefit of insolvent laws extended to him.
