BE IT ENACTED, by the General Assembly of Maryland, That Trustees may pr it shall and may be lawful for the trustees or visitors of Frederick lonery. county school, or a majority of them, to propose a scheme or schemes of a lottery for raising a sum of money not exceeding three thousand five hundred dollars, and to sell and dispose of the - * tickets thereof; Provided, that the said trustees, or a majority of Proviso. them, as aforesaid, do, before the sale or disposal of any ticket or tickets in said lottery, give their bond to the state of Maryland, in the penalty of five thousand dollars, conditioned that they will well and truly apply so much of the money arising therefrom, within three months after the drawing of said lottery, as will satisfy the fortunate adventurers for prizes drawn by them.

And BE IT ENACTED, That after deducting the necessary Apply the money to enlarging build-expenses in said lottery, the said trustees, or a majority of them, ing. shall apply the residue of the money raised by said lottery to enlarging the building in which said academy is held, or in such manner as in their discretion they shall think most promotive of

benefit to said institution.

AND BE IT ENACTED, That the trustees or visitors aforesaid Election of trees. shall, annually, on the first day of January, or within ten days and secretary thereafter, elect by ballot, a treasurer, librarian and secretary, which treasurer shall, within ten days after his election, give bond, in the penalty of one thousand dollars, for the faithful performance of his trust; which said bond shall be lodged in the clerk's office of said county, there to be recorded, for the recording of which the clerk shall receive the sum of fifty cents.
