1. BE IT ENACTED, by the General Assembly of Maryland, That CHAR. 53. Hezekiah Price, Daniel Conn, James C. Dew, William Stansbury, (of Abraham,) and Joshua Gorsuch, of Baltimore county, be and Commissioners appropriate to ascerthey are hereby appointed commissioners, and they, or a majority tained by Jacob of them, are authorised and requested to view and ascertain what Landenslager, damages the said Lacob Landenslager. damages the said Jacob Landenslager has sustained by the road running through his lot of ground, taking into view the advantages and disadvantages, (if any,) and make return of such valuation and damages to the levy court of Baltimore county, to be by them levied at their next meeting that shall happen thereafter, on the assessable property of said county, to be collected and paid, as other county charges are collected and paid, to the said Jacob Landenslager, his heirs or assigns.

CHAP. LIV.

A Supplement to the act*, entitled, An act to confirm a Road in Har- Passed Dec. 7.
1810, ch. 64. ford and Baltimore Counties therein mentioned. Lib. TH. No. 3, fol. 386.

WHEREAS it has been represented to this general assembly, by Preamble. the petition of Elijah Bosley and Sarah Carroll, that a law passed at November session eighteen hundred and ten, authorising commissioners therein named, to lay out a road through the land of the petitioners, with power to assess the damages they might sustain by reason of said road being laid through their land, and the said commissioners did proceed and laid out the same, and assessed the damages they considered the petitioners entitled to, which said allowance the petitioners consider not equal to the damages they have sustained by reason of said road being laid out and opened; and pray that other commissioners may be appointed to value the damages sustained by them, therefore,

1. BE IT ENACTED, by the General Assembly of Maryland, That Damages sustained by Sarah Car-Thomas Watts, Edward Goodwin and Samuel Stone, from Balti-Bosley to be ascer more county, and Thomas Hope, Jesse Jarrett and William Glenn, tained. from Harford county, be and they are hereby appointed commissioners, and they, or a majority of them, are hereby authorised and directed to meet on that part of the road complained of, lying in Baltimore county, on a day by them to be appointed, which day shall be on or before the first day of July next, and after being qualified before some justice of the peace, truly and impartially to estimate the damages sustained by the said Sarah Carroll and Elijah Bosley, by reason of the said road running through their land, so far as the same lies in Baltimore county, they shall proceed to value the same, taking into their consideration the advantages (if any,) and the damages when so ascertained, shall be paid as directed under the act to which this is a supplement.

2. AND BE IT ENACTED, That if the commissioners herein be-Costs, by whom to be paid, fore named shall not allow to the said Elijah Bosley and Sarah Carroll, further damages than have been already adjudged to them by the commissioners under the act to which this is a supplement, then and in that case the said Elijah Bosley and Sarah Carroll shall pay all costs and charges arising under the commission by this act contemplated.
