CHAP. CVII.

An Act to extend the powers of the Levy Court of Talbot County. Passed Dec 921 Lib. TH. No. 3, fol. 443.

WHEREAS it is represented to this general assembly by the pe-Preamble, tition of the trustees of the poor of Talbot county, that the house now used as the poor-house is not only two small to accommodate the number usually under the care of said trustees, but that it is in a decayed state now requiring much repair, that the utmost sum the levy court are allowed by law to raise for the support of the poor is adequate only to their maintenance, and therefore pray that the powers of the levy court of the aforesaid county may be so far extended as to authorise them to levy a sum sufficient to enlarge and repair the said poor-house; therefore,

1. BE IT ENACTED, by the General Assembly of Maryland, That Levy authorised to the justices of the levy court of Talbot county, be and they are house hereby authorised and empowered, to assess and levy on the assessable property of the said county, at their next levy, a sum of money not exceeding one thousand dollars, together with the collector's commission of four per cent. for collecting the same, for the purpose of enlarging and repairing the poor-house of the county aforesaid; which money, when so levied and collected, shall be paid to the order of the trustees of the poor of the aforesaid county, for the purposes contemplated by this act.
