WHEREAS by an act, entitled, An act to alter the time of the Preamble. meeting of the general assembly of this state, and for other purposes, passed at November session eighteen hundred and elevent, + ch. 2:1. it is provided, that the governor and council shall be elected in the month of December, instead of the month of November as heretofore: And whereas, doubts are entertained whether a suspension of executive powers will not thereby occur; for remedy whereof,
