build a bridge over the White Marsh Run in Baltimore county, on CHAP. 154. the road leading from Belle-Air to the city of Baltimore; and the same, when assessed and levied, shall be paid unto Thomas Kell, Philemon Towson and Israel Pearce, who are hereby appointed commissioners to superintend the building of said bridge, and they, or a majority of them, shall and are hereby authorised to employ a workman or workmen to build the said bridge, and the same complete as soon as possible.

2. AND BE IT ENACTED, That it shall be the duty of the said To take bond and security from commissioners to take bond or bonds from the said workman or workmen. workmen, in such penalty and security as the levy court of Baltimore county shall direct, conditioned for the faithful building and constructing of said bridge, and that the said bond shall not be cancelled until said commissioners shall have made report to the levy court of Baltimore county that said bridge hath been finished agreeably to contract.

3. And BE IT ENACTED, That said commissioners, after the Accounts to be rendered to levy completion of said bridge, shall render a full account to the levy court. court of Baltimore county, of all the money expended in building the said bridge, and the money remaining in their hands not expended, (if any,) after the completion of the same, shall be returned to the said levy court for the use of said county.

4. AND BE IT ENACTED, That the said commissioners shall have Discretionary full power and authority to have the said bridge erected either at court. the place where the old bridge formerly stood, or lower down the run, as to them, or a majority of them, may appear most advisable, and to alter the direction of the road as it now runs, so as to meet the location of the bridge, if necessary, fixed by the commissioners aforesaid.

CHAP. CLV.

An Act for the benefit of the Presbyterian Congregation of Queen-Anne's Passed Dec 28. and Caroline Counties. Lib. TH. No. 3, fol. 491.

A Supplement, 1814, ch. 89.

WHEREAS it is represented to this general assembly, by the trus- Preamble. tees of the Presbyterian congregation of Queen-Anne's and Caroline counties, that certain lands have been heretofore conveyed by a certain Thomas Duckery to James Finley and William Price. and by a certain Philemon Thomas to the aforesaid James Finley and William Price, ruling elders of the said congregation, in trust. for the benefit of the said Presbyterian congregation, and by reason of the deaths of the said James Finley and William Price, ruling elders, doubts have arisen as to the validity of the title to the said property; therefore,

1. BE IT ENACTED, by the General Assembly of Maryland, That trustees. the aforesaid lands, tenements and hereditaments, which have heretofore been conveyed by the aforesaid Thomas Duckery to James Finley and William Price, and by a certain Philemon Thomas to the said James Finley and William Price, ruling elders as aforesaid, in trust, for the benefit and use of the said congregation of Queen-Anne's and Caroline counties, be and the same is vested in the present trustees of the said congregation, and the successors of the said trustees, appointed according to the rules and ordinances of the said congregation.
