BE IT ENACTED. by the General Assembly of Maryland. An Act to incorporate the Warren Manufacturing Company. Lib. Passed Feb 5, 1997 TH. No. 5, fol. 399.

WHEREAS it is represented to the legislature, by petition of S. Preamble. Smith and Buchanan, and others, that they have erected a cotton factory on lands owned by them, on the Gunpowder Falls, in Baltimore county, and that they are desirous of increasing their capital stock, by voluntary subscriptions of such persons as may incline to associate with them, to enable them to carry on more extensively the manufacturing of cotton, and to establish and carry on such other manufactures and business as may be deemed useful, and have prayed that they may be incorporated, in order to enable them the more effectually to accomplish their purposes; therefore.

BE IT ENACTED. by the General Assembly of Mariland, That Stockholders in S, Smith and Buchanan, Andrew Clopper, Price and Watson, corporated George Warner, George Harryman, Micajah Merryman, and James A. Buchanan and Co. and all such other persons as shall associate with them by becoming stockholders in the manner hereinafter provided, their successors and assigns, shall be, and they are hereby made and constituted a body politic and corporate, by the name, style and title, of The Warren Manufacturing Company, and by the same name, style and title, shall have continual succession, and shall be capable in law to sue and be sued, plead
