And HE IT ENACTED, That when the new court-house at Ha- when new court ger's town shall be completed, the said moderator and commissioners shall pull down the old court-house, and apply the materials of the same to the erection of the new market-house aforesaid, or sell the same at public sale to the highest bidder, under the express condition, that it shall be pulled down immediately; and the proceeds of the same shall be applied to discharge any debt contracted for building the market-house aforesaid.

5. AND BE IT ENACTED, That the moderator and commissioners Levy nuthorised. of Hager's-town, be, and they are hereby authorised, to levy on the taxable property of Hager's-town, and its additions, such sum or sums of money as will, with the praceeds of the old court-house, be sufficient to pay for purchasing the site and erecting the markethouse aforesaid, and shall collect the same, in two equal moieties, in the year eighteen hundred and nineteen and the year eighteen hundred and twenty.

6. AND BE IT ENACTED, That the eighth section of the act, Section repealed. entitled, "An act to provide for the crection of a new court house in Hager's-town. Washington county." passed at December session cighteen hundred and fifteen*, be and the same is hereby repealed. *Ch. 107

CHAP. XXIX.

An Act for the relief of Robert Atwell, of Anne-Arundel County. Lib, Passed Dec 23 TH. No. 6, fol. 251.

BE IT ENACTED, by the General Assembly of Maryland, That Levy authorised the justices of the levy court of Anne-Arundel county, be and they for his support are hereby authorised and empowered, at their annual meeting, so long as they see cause so to do, to assess and levy on the assessable property of said county, the sum of thirty dollars, for the support and maintenance of the said Robert Atwell, and that the same be collected annually by the collector of Anne-Arundel county, and paid to the said Robert Atwell, or his order.
