That the president shall draw on the treasurer of the western shore, from time to time, for such sums as may be directed by the board of commissioners, and that the said treasurer shall be authorised to pay to the order of the said president, signed by him, and countersigned by the secretary of said board, such sums as he may draw of the said fund, to be applied to the education of the poor children of the county.

BE IT ENAUTED. by the General Assembly of Maryland, That an outside to note in the levy court of Saint-Mary's county shall be, and they are hereby empowered, to borrow, from time to time, such sum or sums of money as they may conceive necessary, provided the same does not exceed two thousand dollars, at an interest not exceeding six per centum per annum, which said loan or loans shall be appropriated and applied by them to the erecting of a guel at Leonard-Town, in Saint-Mary's county; and to cusure the re-payment of the said sum or sums of money, with the interest thereon, the said levy court shall be and they are hereby authorised, to assign and transfor to the lender or lenders thereof, any part or parts of the money authorised to be levied by the act passed at November session, seventeen hundred and ninety-nine, chapter fifty-one, entitled. An act to repair the public gool in Saint-Mary's county, authorising the levy court of said county to assess and levy on the assessable property of said county, a sum not exceeding two thousand dollars,
