CHAP. CXXIII.

CHAP. 123.

An Act for the benefit of Esther Irvin, of Montgomery County. Lib. TH. No. 6, fol. 335.

Passed Feb 5, 1819

BE IT ENACTED, by the General Assembly of Maryland, That Levy such reed the levy court of Montgomery county shall be and is hereby autho- for her support. rised, to assess and levy annually, so long as they shall think fit, on the assessable property of said county, a sum of money not exceeding thirty dollars, for the support of Estace Irvin, and the same shall be collected and paid over to her or her order, in the same manner that other county levies are collected and paid.

CHAP. CXXIV.

An Act to confirm an old Road in Cecil County. Lib. TH. No. 6, Passed Feb 5, 1810 61. 333.

WHEREAS it is supresented to the general(a), that a road in Cecil Promote county, which has been beretofore used as a public road, but which is now about to be saut up by the owner or owners of the land through which the same pesses, to the great injury and damage of many awners of fisheries: And wacreus it is impossible, under the existing law, to obtain an order to have the said road made public, until it shall be too leve for the ensuing fishing season; therefore,

1. BE IT ENACTED, by the General Assembly of Maryland, That Neck confined an old road in Eds Neck, Could county, leading from the place where the road forks near to the house formerly owned by James Waram, and running by or near to John Lande's house, and continuing on as occupied until it intersects a road leading to Turkey Point, opposite to the farm whereon Samuel Aldridge new resides, shall be and the same is hereby confirmed as a public road, and kept up as such in the same manner that other public roads are kept in said county; Provided, that nothing herein contained shall Provise. be construed to prevent the owner or owners of land through which the said road passes from petitioning to the judges of Cecil county court, for damages to be ascertained by commissioners to be appended by said court for that purpose, or to shut up said road as said commissioners may elect.

CHAP. CXXV.

An Act respecting Hay and Straw brought for Sale to the City of Passed Feb 5, 1819 Baltimore. Lib. TH. No. 6, fol. 836.

1. BE IT ENACTED, by the General Assembly of Maryland, That Corporation to provide additional the corporation of the city of Baltimore be and they are hereby hayscales and applicated, on or before the first day of May next, in addition to the hay scales already established, to provide one or more hay scales and apparatus for the weighing of hay brought to the city of Baltimore for cale, one of which scales shall be established in such place in the north western part of the said city as the mayor shall fix and determine on.

2. AND BE ITENACTED. That it shall not be lawful for any fenalty on weigher weigher or his deputy, now or hereafter to be appointed, in and than allowed by for the said city, to ask, demand or receive, more than three cents per hundred weight for weighing any one load of hay or straw. excluding the wagon or cart, and said weigher, or his deputy, shall give a certificate of the same, under the penalty of ten dol-
