16. And BE IT ENACTED, That ordinary discounts may be made CHAP. (86. by the president and six directors, but the president and eight di-Ordinary disrectors shall be necessary for the purpose of transacting any other counts business of the company.

17. AND BE IT ENACTED. That the stock in the North and South Transfers, how to Branch Bank, at Old town, may be transferred by the holder in person, or by power of attorney, at said bank; but all debts actually due to the company, by a stockholder offering to transfer,

must be discharged before such transfer shall be made.

18. And BE IT ENACTED, That dividends of the profits of the Dividends company shall be made at the end of the first year, and half yearly thereafter; and at the end of every three years a dividend shall be made of surplus profits, which dividend shall be payable to the stockholders at the bank.

19. And BE IT ENACTED, That the books, papers, correspon-Books, papers, &c dence, funds, and every transaction of the company, shall at all to be open to inspect our direction of directio times be freely open to the inspection of the directors, a majority of tors. whom, or any number of stockholders not less than thirty, and holding not less than three hundred shares, may at any time call a general meeting of the stockholders for objects relative to the interest of the company, and giving not less than two months notice thereof in the newspaper in the county, and in some public print in the town of Winchester, Virginia.

20. And BE IT ENACTED. That before the president and direc- President, &c. to tors shall act as such, they shall take an oath, or affirmation, that take an oath, they will faithfully, diligently and honestly, perform the duties of their stations; and the cashier, book keeper and clerks, shall also take a similar oath, or affirmation, and shall besides give bonds to the said corporation, with security to the satisfaction of the board of directors, for the faithful discharge of their duties in their several stations.

21. AND BE IT ENACTED. That all notes offered for discount by Notes offered for any person or persons, shall on the face thereof, be made negotiable at the North and South Branch Bank of Potomac, at Old at bank, &c Town, Allegany county; and when the drawer shall not reside in the town of Old-town, such note shall be made payable at the house of some person in the town aforesaid, and notice given by the proper servant of the bank at said house, that such note hath become due, shall be to all intents and purposes held and considered to be as completely binding on the drawer and endorsers as if notice had been personally served on each of them.

22. AND BE IT ENACTED, That any director, officer, or other person holding any share or capital of the said bank stock, who ziement shall commit any fraud or embezzlement touching the money or property of the bank, shall be liable to be prosecuted in the name of the state, by indictment for the same, in any court of law in this state; and upon conviction thereof, shall besides the remedy that may be had by action in the name of the President and Directors of the North and South Branch Bank of Potomac, at Old Town, Allegany county, for the fraud aforesaid, forfeit all his share or stock in the said bank to the company.

23. And he it enacted, That all persons who shall become subscriber incorsubscribers to the said bank, their successors and assigns, shall be porated and they are hereby made a corporation and body politic, by the
