<p>A road to be laid out from the public road on Anne-Arundel Manor to West River,</p>	1812 169

<p>A company incorporated to make a turnpike road from the mouth of Monocacy, through Montgomery county, to intersect the Baltimore and Frederick-town turnpike road at the Poplar Springs, in Anne-Arundel county,</p>	1815 162
<p>The road located by C. S. Ridgely and J. C. Weems, to intersect the New Columbia turnpike road, declared public,</p>	1816 1
<p>A road to be laid out from Magruder's tavern, in Prince-George's county, to Rankin's Ford on the Patuxent, thence to Sappington's Ford, thence to intersect the new road from Baltimore to the Priest's Bridge,</p>	— 225 1817 194
<p>— From the town of Unity, in Montgomery county, to the establishment of Bentley and Co. called Triadelphia, and thence crossing the Patuxent to intersect the road from Roxbury mills to Elk Ridge Landing,</p>	1816 232
<p>— From New-Market to intersect the George-Town road near Griffith's lane, and thence to intersect the old Baltimore and Frederick road near H. Wayman's,</p>	1817 130
