No. 9.

WHEREAS by the act of congress passed on the third of March, one thousand seven hundred and ninety-five, four thousand five hundred copies of the laws of the United States were directed to be published and distributed among the respective states, in such manner as the several legislatures or executives thereof should deem most conducive to the general information of the people, and there being three hundred and eighty of the said copies assigned for the use of this state; therefore; RESOLVED, That the governor laws of U. Sintes. and council send five copies of the said laws to the several county clerks, to be delivered by them, one copy thereof to each of the associate justices of the county court, another copy to the sheriff, another copy to the register of wills, for the use of the orphans courts, and one copy to be kept in their respective offices for the use of the county courts.

No. 10.

RESOLVED FURTHER, That the governor and council deliver or further distribution to be a lead to cause to be delivered a copy of the said laws to each member of the general assembly, to each judge of the general court, and to each chief justice of the county courts; to the chancellor one copy, to the judges of the high court of appeals, each one copy, to the clerk of the court of appeals, for the use of the said court, one copy, to the register or clerks of the corporations of George-Town, and the cities of Annapolis and Baltimore, each one copy, for the use of their respective corporations, to the principals of Saint-John's, Washington, and the George-Town Colleges, each five copies, for the use of the students in the said Colleges, to the principals of all other seminaries of learning now incorporated by the laws of this state, each three copies, for the use of the scholars in said seminaries, to the librarian of the library company of Baltimore five copies, and the secretary of the Somerset library company two copies, for the use of their respective libraries; the residue to be disposed of in such manner as the governor and council, or the legislature, may direct.

RESOLVED FURTHER, That in case of the death, resignation or in case of vacantic dismission from office of either of the officers before mentioned, laws to be deliver-excepting the members of the general assembly, the chancellor, ed to successor, the judges of the court of anneals, and the judges of the general the judges of the court of appeals, and the judges of the general and district courts, the said copies of the laws of the United States delivered to them as aforesaid shall belong to their respective successors in the said offices.

RESOLVED. That William Kilty be and he is hereby appointed to wm.
