under their hands and seals, to the constable of the hundred where CHAP. 29. such lands may lie, commanding him to summon twelve freeholders, not interested in the said lands, to appear on a day by them to be appointed, on the said lands, at which time such freeholders so summoned, shall respectively appear before the said commissioners, and take the following oath, to wit: "I, A. B. do swear, "that I will honestly, without favour, prejudice or partiality, value "the damages and injury sustained by opening a road through the "lands of C. D. in pursuance of this act," and shall return an inquisition of such damages to the clerk of the county court of Queen-Anne's county, and the damages so assessed shall be conclusive.

4. And BE IT ENACTED, That the persons who may conceive Persons interested themselves interested or benefitted by such road or roads, are here-damages assessed. by required to pay, or secure to be paid, into the hands of the commissioners aforesaid, or some one of them, for the use of the person or persons in whose favour such valuation shall be made, previous to laying out and opening the roads aforesaid, whatever damages be as aforesaid adjudged to the party sustaining such damages, and in case of failure of such security or payment as aforesaid, this act to be null and void, but in case of compliance with the provisions of this act, the said roads are to be considered as public roads, and to be kept up in the same manner as other public roads in said county.

5. AND BE IT ENACTED, That if any of the commissioners How vacancies are named in this act shall die, resign, or refuse to act, the remaining to be filled. commissioners, or a majority of them, shall and they are hereby authorised to supply such vacancy, by the appointment of another person.
