WHEREAS it is provided by an act of the general assembly, passed at November session, seventeen hundred and ninety-four, \* entitled, An act for the amendment of the law in certain cases, that the sheriffs bonds shall be hereafter taken on some day between the eighth of October and the first day in January in each year: And whereas Thomas Bailey, the sheriff of Baltimore county, hath not entered into bond agreeable to the above recited act; therefore.

Time for taking bond extended.

2. BE IT ENACTED, by the General Assembly of Maryland, That the time for taking the bond of the sheriff of Baltimore county be extended to the first day of February next, and that if the said sheriff shall, at any time before or on the said first day of February next, give a bond, agreeably to the provisions of the said recited act, the said bond shall have the same effect, to all intents and purposes, as if the said bond had been taken on the thirty-first day of December, eighteen hundred and four.
