An Act to appoint Commissioners for the Regulation and Improvement Paned Jan 27 1206 of Chester-Town, in Kent County, and for other purposes. Lib. PH. No. 1. fel. 154.

WHEREAS it is represented to this general assembly, that the Manbitants of Chester town, in Kent county, would derive great advantages from the appointment of commissioners, with sufficient powers for the regulation of the police of the said town; therefore,

2. BE IT ENACTED, by the General Assembly of Maryland, That pointed Samuel Chew, Benjamin Chambers, James Hodges, Junior, William McKenny, Thomas Worrell, Philip F. Raisin and James Clarposter be and they are hereby appointed commissioners of Chester town in Kent county, and shall continue in office until the time horoin after mentioned for electing commissioners of the said town.

5. AND BE IT ENACTED, That the commissioners appointed by tants to be called this act, or a majority of them, shall on the fourth Monday in missioners. May eighteen hundred and seven, giving ten days previous notice thereof by advertisements fixed at the court-house door and other convenient places in said town, call a meeting of the free white male inhabitants of the said town, to elect, by ballot, seven commissioners for the ensuing year, and the said elections shall be made in the following manners that is to say, the said commissitoners shall appoint some justice of the peace, residing in the said town, judge of the said election, of which they shall give him at least five days notice before the time of holding the said election, and the said testice shall, on or before the day fixed for holding the bear, appoint a clerk to take down the votes for commissioners of the mid town, and the said clerk, before he shall proceed to act as such, shall take an oath, or make affirmation, as the case may be, before the judge of the said election, that he will, truly, faithfully and impartially, take down the names of all such persons as shall be permitted by the judge of the election for commissioners of Chester town to vote at the same, and all free white makes of twenty one years of age and opwards, having resided within Chester town, or the precincts thereof, one whole year next preceding the day of election, shall be entitled to vote for commissioners of the sand town.
