19. And he it enacted. That the treasurer of the western chap. 128. shore be, and he is hereby constituted, a court of inspection; and it shall and may be the duty of the said company, once every year, Treasurer of western shore constituted and oftener if required by the court,) to lay before the same a tuted a court of inspection. See correct and methodical account of their disbursements and expenditures, and of the amount of tolls collected and received on the said road for and during the twelve months preceding, and whenever the tolls shall, during two following years, exceed ten ten per centum, free of all charges on the institution, the said court shall, at their discretion, hold the excess thus arising above the said ten per centum in reserve, to meet any future deficiency, or, if in their judgment a continuance of the then tolls would produce a like annual excess, to lower the tolls, or any of them, so as to bring the argregate on the said road to ten per centum per annum; and the said court may, in their discretion, on the representation of the aforesaid company, revise the tolls herein established, so as to render them in their operation more favourable to the commerce and the industry of the citizens.

mapeetion, &cc.

20. AND BE IT ENACTED, That the stockholders of the present Stockholders enticompany shall be entitled to receive ten per centum per annum, and cent. no more, over and above all charges and deductions whatsoever; and the president and managers of the said company shall keep a just and true account of all and every the monies received by their several and respective collectors of tolls at the several and respective gates and turnpikes on the said road, from the beginning to the end thereof, which account shall be upon oath or affirmation, as the case may be, and shall make a dividend of the clear profits and income thereof, not exceeding ten per centum in any year, among all the stockholders of every description, and shall, on the first Monday in May and November in every year, publish the half yearly dividend made of the said clear profits as aforesaid, and of the time and place when and where the same will be paid, and shall cause the same to be paid accordingly.

21. AND RE IT ENACTED, That all such carriages as aforesaid Two oxen estito be drawn by oxen in the whole, or partly by horses and partly one horse. by oxen, two oxen shall be estimated as equal to one horse in charging all the aforesaid tolls, and every mule as equal to one horse.

22. AND BE IT ENACTED. That if the said company, after the Manner of prosaid road is completed as aforesaid, shall neglect to keep the said company when road in good and perfect order for the space of fifteen days, and pair, ke. information shall be given to any justice of the peace of the neighbourhood, within the county where the repair ought to be made, such justice shall issue a precept, to be directed to any constable, commanding him to summon three disinterested persons, to be named by the said justice in the said precept, to meet at a certain time in the said precept to be mentioned, at the place in the said road which shall be complained of, of which meeting notice shall be given to the keeper of the gate or turnpike nearest thereto; and the said justice shall, at such time and place, on the oaths or affirmations of the said persons, inquire whether the said road, or any part thereof, is in such good and perfect order and repair as aforesaid, and shall cause an inquisition to be made and certified, under the hands of himself and a majority of the said persons, and if
