And Whereupon the Said William in his proper person Complayneth that whereas the Said Hugh [106] the fifteenth day of October in the year of our Lord 1696 at the Charles Towne within the Jurisdiction of this Court was Indebted unto the Said William in the Sume of five hundred forty and Seaven lbs. of tobaccoe being as well for Divers and Sundry Attorneys Fees as alsoe for tobaccoe paid for him the Said Hugh att his Request as by a pertickeler Account thereof here ready in Court to be produced more att Large may Appeare and the Said Hugh inconsideration thereof did Assume upon himselfe and to the Said William then and there Faithfully promise that he the Said Hugh the Said Sume of 547 lbs. of tobaccoe to him the Said William when he Should be thereunto Requested would well and truly Content and pay Nevertheless the Said Hugh his promise and Assumption aforesaid not at all Regarding but minding and fraudulently intending him the Said William in this behalfe Craftily and Subtilly to deceive and defraud the Said Sume of 547 lbs. of tobaccoe to the Said William hath not paid Although the Said Hugh Afterwards the day and place aforesaid was often thereunto Requested butt hath hitherto refused and Still doth Refuse to the Dammage of the Said William of 1000 lbs. of tobaccoe and thereof he bringeth his suite.
