Richard Charletts Administrator plantiffe: Henry Pope Defendant:

Thomas Greenfeild Administrator of the goods and Chattles of Richard Charlett Deceased by William Stone his Attorney brought his Majesties writt of Capias against Henry Pope of a plea that he render unto him the full and Just Sume of five hundred forty and Seaven pounds of good Sound bright and Large tobaccoe cleare of trash and ground Leaves and Caske etc. due by bill as by Declerati[on] and bill filed Appeareth etc. And the Said Henry Pope in his proper person Cometh and defendeth the force and Injury when etc. And Saith that he Cannot gainsay the Action of the Said plantiffe nor but the Said bill (or writeing Obligatory) is the Deed of the Said Henry Pope nor but that he oweth the Said five hundred forty and Seaven pounds of tobaccoe due by bill aforesaid in forme as the Said plantiffe hath Declared against him etc.
