The Grand Jury Came into Court and there being no more business for them was Allowed four hundred pounds of tobaccoe at Mr. Willsons and Soe discharged.

Then did the Court Adjourn for two howers.

John Boyde and Hugh Ryley Came into open Court and Acknowledged themselves to be Security for Thomas Edmonson to pay the Debt and Cost being two thowsand three hundred twenty two pounds of tobaccoe by the tenth day of October next that Francis Harbin Obtained against the Said Thomas Edmonson Last March Court if Soe be the Said Thomas Edmonson doth not pay it himselfe.

Phillip Gittings plantiffe: Christopher Thompson and Grace his wife Administratrix Lawrence Rowland Defendant

Phillip Gittings brought his Majesties writt against the Defendants in a plea of Debt for Six hundred pounds of tobaccoe due by bill as by bill filed Appeareth. And the Defendants in their proper persons Came into Court And Acknowledged the Debt aforesaid to be due to the plantiffe in manner and forme aforesaid.
