Therefore it is Considered that the Said John Soper Recover against the Said Thomas Date as well the Sume of Seaven hundred and Eighty pounds of tobaccoe for his damages in the premises Sustained as Alsoe the Sume of two hundred thirty Six pounds of tobaccoe for his Costs and Charges in this behalfe Sustained to the Said John Soper of his Assent by the Court here Adjudged etc. And the Said Thomas Date in mercy etc.
