Thomas Greenfeild Administrator of Richard Charlett plantiffe: Samuell Warren Defendant.

The plantiffe by William Stone his Attorney brought his Majesties writt against the Defendant in a plea of Debt for two thowsand two hundred forty nine pounds of tobaccoe and the Said Defendant in his proper person Comes and Defends the force and Injury when etc. And prayeth that the Court here would Assigne Auditors to here and Adjust Accounts between the Said plantiffe and Defendant the Said Defendant Alledging that a great part of the Said Debt is already paid According to an Ordinance of Assembly in Such Cases made and provided etc. Whereupon the Court here doth Assigne Auditors (Viz.) Mr. John Wight and Mr. William Wilkinson to Audite and Adjust Accounts between the parties aforesaid and that they make Report thereof to the next Court to be held here the fourth Tuesday in January next etc.

Col. Thomas Hollyday and Mr. David Small to Audite and Adjust Accounts between the parties aforesaid and that they make Report thereof to the next Court to be held here the fourth Tuesday in January next etc.
