Whereupon it is Considered by the Court here that the Said Charles Barrow Recover against the Said John Davis his Damagis aforesaid to the Sume of five hundred thirty Six pounds of tobaccoe as alsoe the Sume of two hundred thirty and two pounds of tobaccoe by the Court here allowed the Said plantiffe for his Cost and Charges in this behalfe Laid out and Expended and by the Court here Adjudged and the Said John Davis in Mercy etc.

The plantiffe Sues the Defendant for the Sume of four hundred Sixty and nine lbs. of tobaccoe due by bill as by Declaration and bill filed Appeareth.
