Wee the Subscribers have Audited and Stated the Accounts between the parties aforesaid According to An Order from this Court in September Court Last And Wee Find the Said Joseph [288] Frys Estate Indebted unto the Said Richard Charletts Estate fourteen hundred and five pounds of tobaccoe.
