Therefore it is Considered that the Said Josias Towgood Recover against the [Said] John Walker As well the Sume of four hundred Seaventy nine pounds of tobaccoe his Debt aforesaid and his Damages by Occation of Deteyning of the Said Debt two hundred and Sixteene pounds of tobaccoe to the Said Josias Towgood of his Assent by the Court here Adjudged of the goods and Chattles which were of the Said John Forrest at the time of his Death in the hands of the Said John Walker to be Administred And the Said John Walker in mercy etc.
