Ordered by the Court that Mr. Cecell finish his records against September Court, and at the Same time to deliver the papers belonging to him as Clerke Now in his possession to Edward Willett the present Clerke.

John Wattkins desiers his marke to be recorded (viz.) a Crop and Slitt on the right year and a Slitt on the left.

Margaret Mutra desiers a bay mare and her Inceas to be recorded for the benefitt of the Children of John Mutra Deceased.

Command was Given to the Sheriffe of Prince Georges County that Imediately hee Summons a Grand Jury to try the Cause between our Sovereigne Lord the King and Matthew Mackeboy, John Wells prosecutor.
