Lett the names of the Pledges be Sought and the said Nicholas Baker goe thereof without day It is Likewise Considered that the Said Nicholas Baker Defendant doe recover against the Said Hides' Executors Plantives the Sume of one hundred and Ninety pounds of Tobacco his Damages by Occation of the premisses by the Discression of the Justices here To the Said Nicholas Baker Defendant for his Costs and Charges by him in this Part Susteined according to the Forme of the Statute etc. by the Court here adjudged. etc.
