

Whereupon the Said Hugh by Joshua Cecell his Attorney comes and defends the force and Injury when etc. and prayeth lycence thereof to imparle here untill the next Court and it is Granted unto him the Same day is given to the Plantiffe likewise.

And now here att this day (to witt) the 28th day of March Annoque Domini 1699 came here as well the Said William Hutcheson as the Said High Ferguson by their attorneyes aforesaid and the Said William Hutcheson prayeth that the Said Hugh Ferguson to his Declaration aforesaid may answer Whereupon the Said Hugh Ferguson by his attorney aforesaid cometh and defendeth the force and Injury when etc. and Saith that he is not informed by the Said Hugh Ferguson in the plea aforesaid and nothing more thereof Saith by which the Said William Hutcheson remaineth against the Said Hugh Ferguson undefended.

Therefore it is Considered that the Said William Hutcheson recover against the Said Hugh Ferguson the Sume of two thousand two hundred ninety and two pounds of Tobacco his Debt aforesaid and his Damages by Occation of deteineing the Said Debt to [pounds of] Tobacco of his Asscent by the Court here adjudged and the Said Hugh Ferguson in mercy.
