Therefore it is considered that the Said Kathrine Willson and Joshua Cecell recover against the Said William Gaskin the Sume of two Hundred fifty five pounds of Tobacco their Debt aforesaid and their Damages by Occation of deteineing the Said Debt to _____ Hundred pounds of Tobacco to the Said Kathrine Willson and Joshua Cecell of their assent by the Court adjudged and the Said William Gaskin in Mercy.
