Att which day to Witt the 22d day of August Annoque Domini 1699 came the Said William Parker by Joshua Cecell his attorney aforesaid but the Said William Jones Though Solemnly Called came not but made default.

Therefore it is Considered that the Said William Parker Plantiffe doe recover against the Aforesaid William Jones Defendant as well the Sume of two Thousand two hundred Sixty and two pounds of Tobacco his Debt aforesaid as allso the Sume of five hundred forty three pounds of Tobacco to the Plantiffe of his Assent for his Cost and Charges of Suite by the Court here adjudged and the Said William Jones Defendant in Mercy.
