Whereupon all and Singular the Premisses by the Court being Seen and understood it is Considered that the Said John Bennett Pay unto our Sovereigne Lord the King as a Fine the Sume of twenty Shillings it is also Considered that he pay unto Edward Willett the master of the Said Clifford for the trouble of his house the Sume of Eight Hundred pounds of Tobacco and the Said John Bennett to continue in Custody till the Fine, the Damages and all Fees Paid to the Officers of this Court, and to give good Security for his good beheaviour and appearance the next Court.
