And the Said Isaack Williams in his propper person Cometh and defendeth the force and Injury when etc. and Saith that he Cannot gainsay the Action aforesaid of the Said plantiffes not but that hee oweth the Said plantiffes the Said Sume of one thowsand ninty two pounds of tobaccoe in manner and forme as in the Accompt above is Expressed.

Therefore it is Considered that the Said Peregrine Browne and Company Recover against the Said Isaack Williams the Sume of one thowsand ninty two pounds of tobaccoe their Debt due by Account aforesaid as alsoe the Sume of
