And Whereupon the Said William by William Stone his Attorney Complaineth that whereas the Said Anthony the first day of November in the year of our Lord 1695 att Charles Towne within the Jurisdiction of this Court was Indebted unto the Said William in the Sume of five hundred Sixty and nine pounds of tobaccoe being for Severall goods by the Said William to the Said Anthony Sould and delivered as by a pertickeler Account thereof here Ready in Court to be produced more att Large may Appeare and the Said Anthony to the Said William in manner aforesaid being Indebted in consideration thereof did Assume upon himselfe and to the Said William then and there Faithfully promise that he the Said Anthony the Said Sume of 569 pounds of tobaccoe to the Said William when hee Should be thereunto Requested would well and truly Content and pay Nevertheless the Said Anthony his promise and Assumption aforesaid not att all Regarding but minding and Fraudulently Intending him the Said William in this behalfe Craftily and Subtily to deceive and defraud the Said Sume of 569 lbs. of tobaccoe to the Said William hath not paid Although the Said Anthony afterwards the day and place aforesaid and att Severall other dayes and times to doe the Same by the Said William was often thereunto Requested but hitherto Refused and Still doth Refuse to the damage of the Said William of 1000 lbs. of tobacco and thereof he bringeth his Suite etc.
