magistrate, in the same manner as debts not exceeding five pounds, any law to CHAP. the contrary notwithstanding.

XIII. And he it enacted, That if any person or persons shall, after the pub-Penalty for lication of this act, cast or throw down, out of any cart, waggon or other car-down rubriage, any rubbish, dirt or earth, in any public street, lane or alley, of the town bish, &c. of Baltimore, fave only in fuch parts and places as shall be appointed and agreed on by the faid special commissioners, every such offender shall forfeit and pay, for every fuch offence, the fum of five shillings, and pay the costs of removing the fame; and if any person or persons, save the said special commissioners, shall hereafter remove or pull down any bar, chain, rope or fence, which the faid special commissioners shall hereafter cause to be set up, in or across the said streets, lanes or alleys, for the preservation of the pavement then newly made, every such person who shall so offend shall forfeit and pay the sum of three pounds for every fuch offence.

XIV. And be it enacted, That if any distiller, soap-boiler or tallow-chand- On distillers, ler, within the faid town, shall discharge any foul or nauseous liquor, from any &c. discharge ftill-house or work-shop, so that such liquor shall pass into or along any of the liquors, &c streets, lanes and alleys, of faid town; or if any soap-boiler or tallow-chandler shall keep, collect or use, or cause to be kept, collected or used, in any of the built parts of the town, any stale, putrid, or stinking fat, grease, or other offensive matter; or if any butcher shall keep at or near his slaughter-house any garbage or filth whatfoever, fo as to annoy any neighbour, or any person whatsoever, he, she or they, being thereof convicted before any justice of the peace of the faid town, shall forfeit and pay, for every such offence, the sum of thirty-

XV. And he it enacted, That if any person or persons shall, after the publi- On persons cation hereof, cast, carry, draw out or lay, any dead horse or other dead carcase, laying dead carcases on or any excrement or filth from vaults, privies, or necessary houses, and shall leave commons, fuch carcase, carrion or filth, without burying the same a sufficient depth in the &c. ground, on any part of the commons of faid town, on or near any of the streets, lanes, alleys or highways, within the faid town, or district adjoining the town, every person or persons so offending, and convicted thereof before any justice of the peace, shall forfeit and pay, for every such offence, the sum of thirty shillings.

XVI. And he it enacted, That if any person or persons shall, after the publi- On throwing cation hereof, cast or throw any carrion or filth whatsoever, or other annoyance filth into the river, &c. or obstruction, into the river in said town, or into the bason, and shall thereof be convicted before any justice of the peace, every such offender shall, for every fuch offence, forfeit and pay a fum of money not exceeding forty shillings, as the faid justice shall think reasonable.

XVII. And he it enacted, That the said special commissioners, the better to A clerk to be enable them to discharge the duties enjoined them by this act, shall choose and appointed, employ a fit and able person for their clerk, who shall make such entries and keep fuch accounts as he shall be directed to do by the special commissioners, for which he shall be allowed such a reasonable reward as the said special commissioners shall agree to, which shall, by an order from the said special commissioners, be paid him by the treasurer.

XVIII. And he it enasted, That the special commissioners have full power to A collector, appoint a person or persons properly qualified to act as collector or collectors of &c. the taxes before mentioned, who is to take instructions from the special commisfioners, to return in a book the persons rated and the things affessed, to call upon the county commissioners of the tax to know the yearly valuation of property within faid town, and to regulate the tax upon every hundred pounds worth of property by faid valuation.
