CHAP. XVII. Commissioners to hear appeals, &c.

XIX. And be it enacted, That appeals may be made by the persons to the special commissioners, thirty days after the assessments are made, and the said special commissioners are hereby required to meet thirty days after notice being given them by the appellants, and examine the persons appealing, upon their legal qualification, concerning the cause of their appeal, which qualification they are hereby authorised to administer, and upon such examination, or other proof, they are hereby empowered to diminish or add to such persons rate or assessment, as to them shall feem just and reasonable.

Collector to account once in fix weeks,

XX. And be it enacted, That the faid collector or collectors shall, once in fix weeks at least, render a just account of, and bring in and pay to the treasurer, all fuch fums of money as he or they shall have received; and the said treasurer shall give receipts to the collector or collectors for what money they shall so bring in and pay, which receipts shall be the collector's discharge for so much; and the faid treasurer shall, from time to time, fignify in writing to the special commisfioners, how much the collector or collectors have brought in and paid; and when the collector or collectors, or any of them, are negligent, or refuse to do their duty, the treasurer is hereby required to fignify the same, by way of complaint, to the special commissioners aforesaid.

To make out a duplicate,

XXI. And be it enasted, That the said collector or collectors make out a duplicate of the persons and things affessed, with the amount of the annual affessment, and lodge the same with the treasurer or special commissioners.

How collection is to be made.

XXII. And he it enaded, That the collection be made monthly, quarterly, or yearly, or in one or more payments, as the special commissioners may direct, notices being previously given in the Baltimore news-papers to this effect.

Penalty on neglect, &c.

XXIII. And he it enasted, That if upon complaint of the treasurer to the special commissioners it shall appear, that the said collector or collectors, having taken upon him or themselves the duties enjoined him or them by this act, shall refuse or neglect to pay the faid sums of money which he or they shall be respectively charged to collect, within the time or times limited by the special commisfioners, he or they, so refusing or neglecting, shall forfeit and pay to the treasurer the fum of five pounds, and shall also pay all the arrearages of such assessment which he was appointed to collect, to be levied by a warrant under the hand and seal of the said commissioners, and directed to the sheriff of Baltimore county, who is hereby authorifed and empowered to execute fuch warrant upon the goods and chattels of fuch collector or collectors, and in case goods and chattels cannot be found, then to imprison such collector or collectors, until payment be made; and every collector so distrained on, and having made full satisfaction as aforesaid, is hereby empowered, without any further warrant, to diffrain for his own use upon all such as neglect or refuse to pay the arrearages due; and the said collector or collectors shall, for his or their trouble, retain in his or their hands fix-pence in the pound for all sums of money by him or them respectively collected.

Penalty on ter, &c.

XXIV. And be it enacted, That in case the vendue master resuses to come to vendue mai- a settlement, quarterly, half yearly, or yearly, or to pay what may appear to be justly due on his fales, he shall forfeit, for every such offence, twenty-five pounds, or a sum not exceeding forty pounds, as may be adjudged by any two impartial persons, one to be chosen by the said special commissioners, and the other by the vendue master, the sum adjudged to be recovered as in case of debt not exceeding five pounds.

Town commissioners to fettle, &c.

XXV. And be it enacted, That the special commissioners are authorised to call upon the town commissioners, for a final settlement of the monies by them collected for repairing of said streets, and in case of refusal to settle, the said town commissioners shall forseit twenty-five pounds; and in case the said town commissioners shall refuse paying to the special commissioners the money due upon a settlement, they shall forfeit double the sum so due, to be recovered as hereaster directed, and applied to the purpose of this act.
