Support, any such person not having and wearing such badge or mark as aforesaid, C H.A.F. and be thereof convicted upon the oath of one or more credible witness or witnesses, he shall forfeit and pay the sum of ten pounds current money.

XVIII. And he it enacted, That who soever shall presume, either to set up a Fenalty on booth, stall, or other convenience for the selling of strong liquors, on the land booth, &c. purchased for the use of the said alms and work-houses respectively, or shall commit any kind of trespass thereon, or shall sell or dispose of any strong liquor, or other matter or thing whatsoever to, or purchase any matter or thing whatfoever from, any poor, or other person entertained in the said alms and workhouses, shall, for every such offence, forfeit and pay the sum of ten pounds current money.

XIX. And he it enacted, That all sheriffs, constables, and all other officers Sheriffs, &c. and ministers of justice, shall be aiding and affishing to the said trustees for the to aid trustees, &c. poor in the faid counties respectively, and to all such officers as shall be employed by them, as by this act is directed, in the execution and performance of the faid service.

XX. And be it enacted, That if any person or persons shall, at any time or Persons sued times, be fued or profecuted for any matter or thing by him or them done and the general executed in pursuance and execution of this act, or of any matter or thing in iffue, &c. this act contained, such person or persons shall and may plead the general issue, and give this act and the special matter in evidence, for his or their defence, and if upon trial a verdict shall pass for the defendant or defendants, or if the plaintiff or plaintiffs shall become nonsuit, or discontinue his or their suit, then fuch defendant or defendants shall have and recover treble costs to him or them awarded against such plaintiff or plaintiffs, and if the plaintiff or plaintiffs is or are unable to fatisfy the same, then it shall be paid and satisfied by the attorney who brought such suit, unless the plaintiff or plaintiffs shall give security for the costs, to be approved by the court in which such suit is brought.

XXI. and, to prevent individuals from being unreasonably burthened with the execution of this act as trustees for the poor, Be it enacted, That at the time A trustee to of the meeting of the said trustees for the poor in the first week of November be chosen annually, &c. yearly, the faid trustees, or the major part of them, in the faid counties respectively, shall and may elect and choose one of the principal inhabitants of their county, to be a trustee for the poor of that county in the stead of the first named or eldest of the said trustees of the same county, which said first named or eldest traftee shall be, and is by virtue hereof, thencefrom discharged from his office.

XXII. And he it enacted, That it shall and may be lawful for the trustees to aforesaid, or a major part of them, to rent an house or houses in the said counties rent an house, &c. respectively for the reception of such poor, vagrants, vagabonds or offenders, with the necessary lot or lots of ground adjoining to such house or houses, as convenient to the court-house in said counties respectively, for the reception and accommodation of the faid poor, vagrants, vagabonds and offenders, until a sufficient sum of money be raised in virtue of this act to enable the said trustees to purchase the land and erect the buildings herein before mentioned, and the justices of said counties respectively are hereby empowered and enjoined, annually, at the court for laying the county rate, to affefs on the taxable property of the said counties respectively, a sufficient sum to discharge the rent aforesaid, with the collectors commission of sive per cent. thereon; which sum so as aforefaid affeffed, shall be collected and paid by the collector of the same county to the faid trustees respectively, or a majority of them, to be by them applied to the purposes aforesaid; and the said trustees, or the major part of them, are hereby empowered and required, as foon as such house or houses aforesaid are procured on rent, to proceed to the appointment of an overseer, and other officers and servants as are mentioned in this act, and to do and perform every other matter and thing necessary to carrying the said act into execution, according to the true intent and meaning thereof.
