other officers by them to be appointed in pursuance of this act, at their discre- CHAP. tion, and to choose others in their place and stead.

XIII. And be it enacted, That the said trustees, or the major part of them, shall, And meet and they are hereby directed and enjoined to meet at the alms and work-house in the year, see. the faid county four times in the year, to wit, in the first week in January, May, August and November, or oftener, if it should by them be deemed necessary, to make and ordain, by a majority of votes of such as may be present, all such good and wholesome ordinances, rules and by-laws, as they shall think convenient and necessary for the direction, government and support, of such alms and work house; and also for the maintenance and employment of all such poor persons as shall be taken under their care, and of all vagrants, beggars, vagabonds, and other offenders, that shall be committed thereto by virtue of this act; all which ordinances, rules and by-laws, shall be, from time to time, inviolably observed by all persons concerned, according to the tenor and effect thereof.

XIV. And he it enacted, That the said overseer shall keep a fair and regular Overseer to If the of all poor, and of all beggars, vagrants, vagabonds, and other offenders, who of all poor, shall be committed to the said alms and work-house; and also fair and regular &c. accounts in writing of all materials, and other things, coming to his hands as overfeer aforefaid, and of all expences and charges attending their maintenance and support, and of all monies received by him for the sale of the produce of their labour, and otherwise, as overfeer aforesaid, and shall lay the said lists and accounts before the trustees, or the major part of them, at their meetings at the times by this act directed, or oftener, if by them required.

XV. And he it enacted, That the faid overfeer may compel and oblige any And may of the faid poor, beggars, vagrants and vagabonds, or other offenders, in his to work, &c. alms and work-house, if of sufficient ability, to work and labour, and the produce of their labour he is hereby directed and empowered to appropriate to and for the use of the said poor, beggars, vagrants and vagabonds, and other offenders, in his alms and work-house, or to sell the same, and apply the money ariting from such sale to their maintenance and support.

XVI. And he it enacted, That upon complaint made, that any person, from Disorderly his or her disorderly conduct, gives disturbance to his or her neighbourhood, and be commitis likely to become chargeable to faid county, it shall and may be lawful for ted, &c. any one magistrate of the said county, if upon hearing the party he shall judge the complaint to be well founded, to commit such disorderly person, residing within the faid county, to the faid work-house, for any time not exceeding three months, unless he or the shall find security, at the discretion of the magistrate aforesaid, in any sum not exceeding ten pounds current money, for his or her good behaviour during the space of six months; and also upon complaint and due proof made by the overfeer of the said alms and work-house to any one trustee, that any person in the said work-house hath behaved and demeaned him or herself in a disorderly manner, or hath resused or neglected to do and perform his or her daily labour and task, or hath refused or neglected to obey, keep and observe, any of the ordinances, rules and by-laws, of the faid corporation, to order and direct such moderate and proper correction, not exceeding ten lashes for any one offence, to be given to fuch offender, as the nature of the case may require.

XVII. And he it enacted, That it shall and may be lawful to and for any of Trustees to the said trustees to direct and appoint, under their hand in writing, what poor poor shall be shall be received into such alms and work-house; and it shall and may be lawful received, &c. for any one justice of the peace for said county, and for any person authorised and appointed by such justice, to apprehend, or cause to be apprehended, and committed to the faid work-house, any vagrants, vagabonds, beggars, and other idle, dissolute, and disorderly persons, found loitering or residing in the said county, who follow no labour, trade, occupation or business, and have no visible means of subfiftence, whereby to acquire an honest livelihood, there to be kept
