- to repeal Sections 237 to 259, both inclusive, of Article 24 of the Code of Public Local Laws, title 'Worcester County,' sub-title 'Snow Hill,' and to repeal all Acts or clauses of Acts heretofore passed by the General Assembly of Maryland with reference to the charter of the town of Snow Hill, in Worcester County, in conflict with the provisions of this Act, and to reenact and grant to the town of Snow Hill, in Worcester County, a new charter"..... 262
- No. 154. An Act to repeal Sections 49 and 50 of Article 25 of the Public General Laws of Maryland, title "County Commissioners," sub-title "Draining Lands," as amended by the Act of 1892, Chapter 649, so far as the same apply to tax ditches or drains situate wholly within Somerset County, and to enact in lieu thereof certain provisions applicable to tax ditches or drains situate wholly within said county..... 264
- No. 155. An Act to authorize and direct the Comptroller of the State Treasury and the County Commissioners of Baltimore County, respectively, to refund to George Brehm and Henry A. Brehm, copartners, trading as George Brehm & Son, money paid by them for liquor license granted or to be granted to Amon Dorsey for the year 1903-1904, which license was never taken from the clerk's office of the Circuit Court of said County ..... 265
- No. 156. An Act to incorporate the Cecil County Bar and Law Library Association and to provide means for maintaining the same ..... 266
- No. 157. An Act to declare the sanction of the General Assembly to a bequest of \$2,500, with the collateral inheritance tax to be paid by the estate of Miss Willie Swann, of the City of Baltimore, to Emmanuel Protestant Episcopal Parish, of Allegany County, Maryland..... 267
- No. 158. An Act to authorize the Board of County School Commissioners of Dorchester County to pay, in their discretion, to Thomas I. Wright, of said county, the sum of two hundred dollars, with interest from the 22d day of October, 1892, for money paid by him to the said Board for certain real estate.... 268
- No. 159. An Act to amend the charter of "Perry Hall Methodist Episcopal Church, South," a body corporate, by granting to said corporation perpetual succession, and by authorizing it to hold, own and maintain a cemetery or burying ground, and to acquire, hold and administer funds for such purposes; and to authorize it to do and maintain all things declared in its certificate of incorporation to be objects and purposes of said corporation ..... 269
- No. 160. An Act providing for the repairing, improving and building an addition to the Cambridge Female Seminary Building, and providing heating apparatus therefor, in the town of Cambridge, Dorchester County, Maryland, and to authorize and require the Board of County School Commissioners of said
