- No. 355. An Act to repeal and re-enact with amendments Sections 156, 157, 174, 180, 185, 270B, 270G, 270J, 270N, 270P, 270W and 270Y of Article 11 of the Code of Public Local Laws of Maryland, title "Frederick County," sub-title "Frederick City," relating to registration and elections in said city, as the same were amended by the Acts of 1898, Chapters 1 and 2..... 585
- No. 336. An Act to repeal and re-enact with amendments Section 11 of Article 48 of the Public General Laws of Maryland, title "Inspectors," sub-title "Tobacco"..... 595
- No. 337. An Act to add an additional section to Article 23 of the Code of Public General Laws of Maryland, title "Corporations," sub-title "General Regulations," to follow immediately after Section 85L of said Article, to be known as Section 85L1 of said Article relating to the liability of stockholders to creditors and depositors of safe deposit, trust, guarantee, loan and fidelity companies 597
- No. 338. An Act to authorize the Mayor and City Council of Baltimore to issue the stock of said corporation to an amount not exceeding one million dollars for the extension of the present park system of the City of Baltimore, and for the development and improvement for park purposes of the lands over which it shall be so extended, in such manner as the Mayor and City Council of Baltimore shall by ordinance prescribe; to authorize the submission of an ordinance to that end to the legal voters of said city; to empower the Mayor and City Council of Baltimore to acquire, by condemnation or otherwise, within the City of Baltimore, and Baltimore, Howard and Anne Arundel Counties, such lands or properties as may be necessary for the purposes of such extension; to develop and improve the same for park purposes, without regard to the provisions of Section 840 of Article 4, entitled "City of Baltimore," of the Code of Public Local Laws of Maryland, as amended by Chapter 453 of the Acts of the General Assembly of Maryland, approved April 8, 1902..... 598
- No. 339. An Act to repeal and re-enact with amendments Sections 50 and 114A of Article 33 of the Code of Public General Laws, title "Elections"..... 601
- No. 340. An Act to incorporate the Fidelity Appraising and Auditing Company of Baltimore City..... 603
- No. 341. An Act to repeal and re-enact with amendments Sections 52 and 54 of Article 72 of the Code of Public General Laws, title "Oysters," and to add three new sections to the said Article to be known as Sections 8A, 55A and 55B, to follow Sections 8 and 55 respectively..... 605
- No. 342. An Act to regulate the building of bridges across the Monocacy river within one and a-half miles of the Iron Stone Ridge, at a point commonly known as Stump's Hill in Frederick County, Maryland, and to enable the County Commissioners of Frederick County to purchase, lease or condemn the stone
