- No. 475. An Act to repeal Section 40 of Article 11 of the Code of Public Local Laws of Maryland, title "Frederick County," subtitle "Birds and Game," as enacted by Chapters 550 and 587 of the Acts of 1900, and Section 43 of said Article 11 as enacted by Chapter 303 of the Acts of 1872, and to re-enact the same with amendments. 830
- No. 476. An Act for the creation of a Tuberculosis Commission. . 831
- No. 477. An Act to repeal and re-enact with amendments Chapter 547 of the Acts of the General Assembly of Maryland, passed at the January Session, 1900, entitled "An Act to authorize the County Commissioners of Dorchester County to borrow money on the credit of the county for the purpose of constructing a bridge across the northwest fork of the Nanticoke river, in said county, at a point called 'Harrison Ferry,' and placing a draw therein;" to give their bond or bills obligatory for the payment of the same, and to levy taxes on the assessable property of said county to redeem said bonds or bills obligatory and to pay the interest thereon; and also to levy any additional sum necessary to construct said bridge. 832
- No. 478. An Act to appropriate a sum of money to meet the deficiency for the printing of the General Assembly of 1904. 833
- No. 479. An Act to repeal Section 1 of Chapter 332 of the Acts of 1900, entitled "An Act to regulate the compensation of the County Commissioners of Allegany County and to re-enact the same" 834
- No. 480. An Act to refund to Robert H. Simpson, executor of the estate of Anthony J. Kelly, deceased, fifteen dollars, being a sum of money erroneously paid as collateral inheritance tax by him to Stephen R. Mason, Register of Wills of Baltimore City, on the estate of Anthony J. Kelly, deceased, on which no collateral inheritance tax was due, and which sum of money was conveyed into the Treasury by said Register of Wills. 835
- No. 481. An Act to repeal Chapter 416 of the Acts of the General Assembly of Maryland, passed at January Session, 1902, entitled "An Act to empower and require the Board of County Commissioners of Frederick County, Maryland, to provide for free scholarships to students of Frederick County in the Buckeystown Normal School in said county" 835
- No. 482. An Act for the better protection of game birds, song birds, insectivorous birds in Calvert County and St. Mary's County 836
- No. 483. An Act to empower, authorize and direct the County Commissioners of Charles County to levy at their next levy, laying a sum of money to the use of Alice M. Cox, trustee of
