An Act to add an additional section to Article 54 of the Code of Public General Laws of Maryland, title "Land Office," sub-title "Commissioner of the Land Office, His Powers and Duties," to be designated as Section 2A, providing for the appointment of an index clerk of the Prerogative Court and High Court of Chancery Records.....	850

An Act to add an additional section to Article 22 of the Code of Public Local Laws, title "Washington County," sub-title "Hancock," to follow Section 241 and to be designated as Section 241A, giving power to the Burgess and Commissioners of Hancock to regulate, license and tax restaurants, breweries and all saloons and other places where malt, spirituous, vinous and fermented liquors are sold.....	851
