No. 536. An Act to appropriate a certain sum of money to the Elkton *Appeal* for publishing notice of the proposed constitutional amendments authorized to be submitted to the vote of the people under the provisions of Chapters 185, 432 and 469 of the Acts of 1900..... 921

No. 537. An Act to repeal Section 4 of the Acts of Assembly passed at the January Session, 1866, Chapter 53, entitled "An Act amendatory of an Act to establish and endow an agricultural college in Maryland, passed at the January Session, 1856, Chapter 97, and of a supplemental Act passed at January Session, 1858, Chapter 265, as said section was repealed and re-enacted with amendments by the Act passed at the January Session, 1880, Chapter 231, and as said section was repealed and re-enacted with amendments by the Act passed at the January Session, 1888, Chapter 326, and to re-enact the same with amendments 922

No. 538. An Act to repeal Sections 138, 139, 140, 141, 142, 143, 144, 145, 146 and 147 of the Code of Public Local Laws, title "Prince George's County," sub-title "Fences," and to re-enact the same with amendments..... 923

An Act to amend Article 1 of the Code of Public Local Laws of the State of Maryland, title "Allegany County," sub-title "County Commissioners," by adding thereto a section to be designated as Section 37A, authorizing and directing the County Commissioners of Allegany County to annually levy to the incorporated town in said county the sum of ten thousand dollars 926
