Bequest of \$10,000

(22) To the bequest of William Wyman, late of Baltimore City, Maryland, deceased, made by his last will and testament duly recorded in the office of the Register of Wills of Baltimore City aforesaid, of ten thousand (\$10,000) dollars to the Vestry of Grace Church of Baltimore City, State of Maryland.

How income is to be used
