7. If any person shall neglect or refuse to have his, her or their beams and scales, weights and measures inspected and adjusted as herein directed when required to do so by the proper officer, he, she or they shall forfeit and pay a fine of five dollars for every day during such delinquency.

If any standard keeper shall be informed or has reason to suspect that any person is using or has in his possession with fraudulent intention and* false beams, scales or measures, he shall examine the same, and if he finds them or any of them to be false, he shall seize the same as a forfeiture, and adjust and sell them at public auction, and shall annually return a statement of the money received therefor under oath to the county commissioners.
