- 333. Water supply or sewerage system which becomes nuisance and which cannot be remedied by change of method in operation, board may remedy; alterations or extensions; new system or plant.
- 334. When waters of state become polluted or dangerous to health due to lack of a system of public water supply or sewerage disposal, or in case of lack of public system of water supply or sewerage disposal, board may pass orders remedying conditions.
- 335. Counties, cities, corporations, etc., desiring to install water supply or sewerage system for public use to apply to Board of Health for permit; when work completed certified copy of plans to be filed with board; board to prescribe rules and regulations and outline them to applicant; permits or refusals to be issued promptly.
- 336. Counties and cities to raise funds in order to comply with order of Board of Health; issue of bonds, stocks. etc.; same need not be submitted to vote; expenditures of public money to be approved by Board of Health.
- 337. Before land platted for sub-division is marketed or permanent buildings erected thereon, plans for water and sewerage to be submitted to Board of Health; board may order additional plans and installation of system.
- 338. Waters polluted by wastes from manufacturing or industrial establishments; board to order discontinuance of, and changes in method; permits; plans showing existing methods submitted to board.
- 339. Where water or ice is from source which is or likely to become dangerous, or sewerage is or is likely to become dangerous, Board of Health may close up source or place of sewage discharge; changes to remedy conditions; condemnation of sources of supply or sewage disposal.
- 340. Property upon which there is a spring, well, cesspool, privy, etc., which may

- become prejudicial to health, may be ordered connected with water supply or sewerage system if there is one available, and spring, etc., abandoned; board may prevent construction of well, cesspool, privy, etc.; condemnation of structures.
- 341. Board of Health to have supervision over water for potable purposes and method of bottling, etc.; permits; water from outside of Maryland.
- 342. Board of Health to have supervision over ice used for domestic purposes; permits; place of storage and handling of; rules and regulations.
- 343. Records to be kept by counties, cities, corporations, etc., supplying water, ice or sewerage service; access to buildings.
- 344. Permits revocable and subject to change after notice; permits issued for specified period.
- 345. Counties, cities, corporations, etc., may appeal from order of Board of Health; procedure; action to have precedence; appeal to Court of Appeals.
- 346. Penalties for failing to comply with order of Board of Health or of court on appeal.
- 347. Board of Health may employ experts, engineers, etc.; expenses thereof; compensation.
- 348. Appropriation.

- 349-352. Board of Osteopathic Examiners; appointment; qualifications; term of office; vacancies; death; meetings; officers.
- 353. Examinations, how conducted; report and license.
- 354. Fees; compensation and expenses of board.
- 355. License to persons practicing osteopathy in Maryland on April 13, 1914; requirements; fee; records of board.
- 356. License to persons beginning practice of osteopathy in Maryland after April 13, 1914; requirements; persons practicing in other states; examination, result of to be reported; subsequent examinations.
