Any person under the age of twenty-one years who knowingly and wilfully makes any misrepresentation or false statement as to his age, and by reason of such misrepresentation or false statement obtains any spirituous or fermented liquors from any other persons licensed to sell such spirituous or fermented liquors under the laws of this State shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be fined not less than one dollar nor more than twenty dollars or be imprisoned in jail for not less than five days nor more than thirty days, or be both fined and imprisoned, in the discretion of the court; provided, that the testimony given by any minor or person under twenty-one years of age in the prosecution of any person for selling liquors to minors under the laws of this State shall not be used against such minor in prosecution under this section.

Any person under the age of twenty-one years who shall knowingly and falsely represent himself to be twenty-one years of age to any licensed inn keeper or other person engaged in the sale of intoxicating liquors, for the purpose of procuring or having furnished to him, by sale, gift or otherwise, any intoxicating liquors shall be deemed guilty of a misdemeanor, and upon conviction thereof in any court of competent jurisdiction shall be sentenced to pay a fine of not more than twenty-five (\$25) dollars or imprisoned in jail for a period not exceeding thirty days.
