

the fine shall be paid to the informer causing the arrest and conviction, and the remaining one-half shall be paid to the State Comptroller of this State or the State Game Department to be credited to the State Game Protection Fund to be used as provided by law.¹

Shipping Game Out of State.

97. It shall be unlawful to export or ship out from the limits of the State of Maryland any wild game; water-fowls excepted; and it shall also be unlawful for any express company or any common carrier, to knowingly accept any game, water-fowls excepted, for shipment without the State. Provided, however, that any hunter who has obtained the necessary license to hunt within the State of Maryland, or any county thereof, shall be permitted to carry out with him as personal baggage, for own use and not for purpose of selling same, an amount of game killed by himself equal to one day's bag limit, upon exhibiting his license, if so required. Any game shipped to points within the limits of the State shall be plainly and conspicuously marked as game.

Any person or corporation violating the provisions of this section shall be liable to a fine of not less than Twenty-five nor more than one hundred dollars for each and every offense, upon conviction before any Justice of the Peace of the State.²

Hunting Licenses.

98. For the purpose of providing a fund for the payment of the expenses of protecting and propagating certain birds and animals, and preventing unauthorized persons from killing the same, no person or persons shall at any time hunt, pursue or kill or trap in any manner any Game as defined in Section 59 of this Article, or any birds or animals on which there is an open and closed season, without first having procured a license to so hunt, pursue or trap, and then only during the respective periods of the year when it shall be lawful to hunt, pursue or trap birds and animals. The said license shall be procured from the Clerk of the Circuit Court of any county, or from the Clerk of the Court of Common Pleas of Baltimore City, in the following manner, to wit:

The applicant shall fill out, sign and forward to the Clerk of Court a blank application to be furnished by the State Game Warden through the clerks of said courts, stating the name, age, color, height, color of eyes and hair, occupation and place of residence of the applicant; application for any such license may be made through the mails. The applicant, if a non-resident of the State of Maryland, shall pay to the Clerk of Court in which he files his or her application, the sum of ten dollars (\$10) as a license fee; if a non-resident landowner of any county to the assessed value of
