**25.** He shall cause to be printed, in the forms prescribed by law or usage, blank marriage licenses, traders' licenses, ordinary licenses, non-resident licenses, brokers' licenses, hawkers' and peddlers' licenses, exhibition licenses, billiard-table licenses, wood-hucksters' licenses, and all other licenses issued by the clerks of the courts of this State, and now authorized by law, with the several rates, grades and descriptions thereof, with reference to the character and object of said licenses, the sum to be paid therefor, and the fractional part of the year, not less than one month or any number of months for which the same may be issued; and upon the requisition of the clerks of the several circuit courts, and of the court of common pleas, shall forthwith deliver to the said clerks the number and description of licenses required by them for one year, or the fractional parts of the year, terminating on the thirtieth of April then next ensuing, and shall take a receipt from the several clerks therefor.

**26.** He shall have inserted in all ordinary licenses a clause specially excepting the Sabbath day, commonly called Sunday, from the operation of said licenses.
